Series runs from 1<sup>st</sup> Jan to 31<sup>st</sup> Dec. POINTS – 1<sup>st</sup> 15 - 2<sup>nd</sup> 12 – 3<sup>rd</sup> 10 – 4<sup>th</sup> 8 - 5<sup>th</sup> 6 – 6<sup>th</sup> 5 – 7<sup>th</sup> 4 – 8<sup>th</sup> 3 – 9<sup>th</sup> 2 – 10<sup>th</sup> 1

ENTRY FEE - Solo's - £15 - plus Club Membership £5.00

COURSE – Entirely on private land approx 2 miles per lap and include 6 observed sections. Each event will last approx: 1 hour and the rider who completes the most laps in the shortest time will set the standard time, which must not exceed 20 mph average. Riders who exceed speed average, miss sections or cut the course will be disqualified. Riders will be started in pairs at 10 sec. intervals in numerical order. MARKING – Clean 0 - Footing 3 - Stop 5 = Passenger touching ground 5 – Missed section 5 – Course Cutting Exclusion – Ties – Fastest overall time then the highest number of cleans. PROTECTIVE CLOTHING – Boots, Helmet & Gloves must be worn. ALL RIDERS MUST DISPLAY NUMBERS IN APPROPRIATE BIBS - PROTESTS – In accordance with NSC of the ACU to Secretary of meeting within 15 days.

This event is held under the National Sporting Code of the ACU, the Standing Regulations, Supplementary Regulations and any final instructions issued for the meeting. The ACU National Sporting Code & Standing Regulations are published in the ACU Handbook.
