ENTRIES To the secretary not later than 1 hour before the start time.

FEES Solos £10.00

CLASSES Open to any type of solo or sidecar machine. Class 1 solos on Trials tyres.
Class 2 solos on Moto-Cross or Enduro tyres.

AWARDS Premier; for the best performance in each class.
Runner Up; for the next best performance overall.
1st Class; for the next best 15% of starters in each class.
Best 'B' Class for the best Trials Intermediate.
Best 'C' Class for the best Trials Novice.

All awards subject to a minimum of 6 entries in that class.

COURSE At Fairy Hill, Compton Dando. which is all on private land. 6 observed sections Included on each lap, all of which must be attempted. Failure to attempt a section, or course cutting will result in disqualification. Length of course will be decided by the number of laps completed in 1 hour by the fastest rider. (Average speed not to exceed 20 mph).

START will be at 10.30 am with 2 riders away every 10 seconds, starting in numerical order. Maximum number of starters is 60.

FINISH Drivers remaining after fastest rider has finished will be allowed a further 10 minutes to complete the given number of laps.

MARKING	Observation: Clean 0	Time: 1 mark lost for every 30 seconds
	Footing 3	after fastest rider allowing for starting
	Stop or fail 5	time differential. (Max penalty 20
		marks lost).

TIES Will be decided by (a) fastest overall time. (b) most cleans.

CLOTHING Protective clothing, boots, helmets and gloves must be worn.

NUMBERS Numbers will be provided by the Club. These must be inserted in pockets in bibs which can be purchased or hired from the Club. All numbers must be returned immediately after the trial – penalty £5.

WARNING Drivers who are considered to be driving in a dangerous manner will be disqualified.
